#### **CORRIGENDUM & ADDENDUM**

#### No.MTC/MD/RFP/2020/749/77

#### Dated Shillong, the 24<sup>th</sup> February 2020

With reference to the Tender notice no.MTC/MD/RFP/2020/749/44 dated 07.02.2020 for "Selection of an Airline Operator to provide Flight services between Delhi and Shillong" amendments to the RFP are notified as below. All other requirements, information and terms & conditions shall remain unchanged.

#### **A.** The following Section 3.7 of the RFP:

#### " 3.7 Minimum Eligibility Requirement

Bidders who comply with the following criteria are eligible for participation in this tender:

All Regional Carriers, Scheduled Carriers and International Carriers, who are qualified to operate the mentioned sector are allowed to participate in the bid. Supporting documentary evidences should be provided for each criteria.

- The Bidder as a Company must be currently in the aviation business of airoperations under valid Air Operator's Permit (AOP) for the last five years from the last date of submission of the tender.
- 2. The Bidder should have experience of providing ticketed passenger services for at least two years
- 3. Aircraft under its ownership / wet lease (with documentary proof)
- 4. Copies of currently valid Certificate of Airworthiness (C of A), C of Registration (C of R), Weight Schedule, etc. issued by DGCA, BCAS and other competent authorities, for the operation of the Aircraft service must be furnished along with the Technical Bid.
- 5. Turnover of the Bidder for the last 3 financial years (2016–17, 2017–18 & 2018–19) should be at least Rs 25 crores in each FY
- Bidder should have positive Networth in each of the last 3 financial years (2016-17, 2017-18 & 2018-19)
- 7. Plane model: 40 80 seater for Delhi Shillong– Delhi Sector
- The age of the Aircrafts offered must not be more than 15 years as on 31<sup>st</sup> December 2019

- The Operator's (Bidder's) and its Board of Directors Security Clearance should not have been rejected by the Ministry of Home Affairs in the preceding 10 (ten) years. Self declaration should be submitted to this effect.
- 10. A Certificate from the Statutory Auditor to the effect that the Bidder has requisite financial capacity to carry out the agreement work in addition to their existing business and about the Average Annual Turn Over of last three financial years (2016-17, 2017-18 & 2018-19) etc. as specified in the tender must be enclosed in the Technical Bid.
- 11. The Operator (Bidder) should not have been established by DGCA to have been involved in any fatal accident in the past 03 years (self declaration to be attached).
- 12. Should have PAN/ TAN of Income Tax Department.
- 13. Should have GST registration number.
- 14. The Bidder (Operator) should submit in original a Solvency Certificate from a nationalized / scheduled bank."

#### "3.7 Eligibility Criteria

Bidding under the Scheme shall be permitted only by the airline operators having: 1) A valid Scheduled Operator's Permit (SOP) or a Scheduled Commuter Operator (SCO) permit for scheduled air transport service (passenger) issued by the DGCA, or

2) A valid Non-Scheduled Operator's Permit (NSOP) for nonscheduled air transport service (passenger) issued by the DGCA, or

3) A valid air operator permit or equivalent permit issued by the competent civil aviation regulatory authority of any foreign country, or

4) Entities which do not have a valid AOP at the time of bidding under the Scheme, but which have applied for an initial No Objection Certificate (NOC) from MoCA, as per applicable regulations, for obtaining Air Operator Certificate (AOC) for Scheduled Passenger Air Transport Service or Scheduled Commuter Air Transport Services before the last date of Submission. In the event that any of the Bidder eligible under this section above is identified as the Selected Airline Operator, such Applicant must obtain a valid AOC from the Directorate General of Civil Aviation (DGCA) before commencement of operations for MTC / Government of Meghalaya."

- (c) The selected operator should ensure that the booking of non-VGF seats for a particular flight is initiated for booking only after all the VGF seats have been booked. The MTC / Government of Meghalaya may get the same verified by a competent third party auditor from time to time
- (d) In the event of more than one bidder quoting exactly the same amount for V, the Committee shall be at liberty to exercise discretion based on the information provided in the *"Annexure-4 Technical and other information "* and in Annexure-7 of the RFP.

- (i) After completion of negotiations with the preferred bidder, the Authority shall award the work to the selected Bidder by Issuing a Letter of Invitation (LoI).
- (ii) The Successful Bidder with whom the agreement is signed is expected to commence the Flight Operations on or before 7<sup>th</sup> March,2020. "
