In accordance with Govt. approval Sealed Tenders are invited under Two Bid System from the Manufacturers/Contractors/Individual/Firms having such capacity for entering into the Rate Running Contract on PPP Mode for 3 (three) years in line with Clause III of the Meghalaya State Policy for Weighbridges, 2018, for construction of new 100 MT capacity pit less / shallow pit Electronic Lorry Weighbridges with digitizer and printer including civil works for the weighbridge i.e foundation, approach ramps/Roads and cabin etc and also for Annual Maintenance of such lorry weighbridges to set up within the vicinity of **Borsora, South West Khasi Hill.**

**Rate Running Contract for Supply, Construction, Installation, Testing and Commissioning of new 100 MT Capacity fully Electronic/Movable-Type pit-less/Shallow pit Lorry Weighbridge, surface mounted Complete with 9mx3m, & 16mx3m platform, compression/shear beam type Load Cells, Digital Weight Indicator Personal Computer with alpha numeric Key Board, Recording and printing units along with UPS Installation of integrated Check Point at the above Govt. Land, including construction, development of Land to accommodate Directorate of Mineral resources, Police and Transport Officials.**

2. a) Technical Bid: With the commercial details should be submitted in the envelope marked 'A' Technical Bid along with Earnest Money, Name of the work should be superscribed on the cover.
- (b) Price Bid: Should also be submitted on the same date in a separate envelope marked 'B' Price Bid. Price Bids will not be opened on the date and time of the tender opening. Price Bids of only such Tenderers, whose technical bids are found technically and commercially acceptable, will be opened subsequently on a date and time fixed by the Govt. (Commissioner of Transport), which will be intimated to them.
- (c) The minimum bid for Rate Running Contract (RRC) for the Weighbridge after complete installation of all the apparatus and civil works shall be above Rs.50,00,000/- (Rupees Fifty Lakhs) only; annually subject to revision as proportionate to enhancement of weighment fee from time to time.
- (d) Cost of the installation, transportation of materials and apparatus, development of land infrastructures including staff quarters, payment of employees, provision of sanitation facilities will be borne by the successful tenderer.

- (e) it shall be the responsible of the successful bidder/tenderer/weighbridge operator to obtain permission from the State PWD (R)/ or National Highway Authority of India (NHAI) to construct, install, operate at the designated places, if necessary.

The tender without specified tender cost will summarily be rejected and technical/price bid envelopes will not be opened for such bidders.
