No.TPT. 34/91/387- In exercise of the powers conferred under sub-Section (2) of Section 4 of the Meghalaya Requisition and Control of Vehicles Act (The Assam Act V of 1969 as adapted by Meghalaya), the Governor of Meghalaya is pleased to Order that the Owners of the following Categories of vehicles shall be paid compensation at the rate shown below when the vehicles are requisitioned by Government for public purposes.

This notification shall come into force with immediate effect. This supersedes the earlier Notification No.TPT. 34/91/345, dated 26.11.2010.
