- Tender will be received by undersigned up to 14:00 hrs on 22nd May, 2017 and will be opened on the same day at the 16:00 hrs at the office of the Commissioner of Transport, Meghalaya, Shillong in presence of the Tenderers or Representatives if any.

Terms & Conditions

1. Tender should be quoted separately for each item to be accompanied by the Earnest Money. Earnest Money as far as practicable should be in a form of Deposit at call duly pledged in favour of the Commissioner of Transport, Meghalaya, Shillong.
2. Rate quoted for each vehicle in Tender should be written clearly both in figures and in words. Any over writing should be duly and properly self attested.
3. Tender should be addressed to the undersigned by designation and not by name. Sealed envelope containing the Tender must be super scribed by words "Tender for purchase of condemned vehicles" may be sent by a registered post or by Deposited in the Tender box located in the office of the Commissioner of Transport, Meghalaya, Shillong.
4. The following documents should be attached with Tender, Tender received without the required documents will be summarily rejected.
 - a. Attested copy of Photograph of the Tenderer.
 - b. Earnest Money at 10% of the bid Money be submitted duly pledged in favour of the commissioner of Transport, Meghalaya, Shillong.
 - c. Up-to-date trading License in terms of KHADC Regulation Act to whom so ever is applicable.
5. The intending Tenders may inspect the condemned vehicles at the office premises on any working days from 10:00 hrs.
6. The successful Tenderers shall be intimated and a letter of acceptance will be issued by the Undersigned.

7. The successful tenderers shall have to deposit the full amount of the tender cost through Treasury Challan within 1 (one) week of issuing of the award of tender and remove / lift the vehicles within 15 days after furnishing the copy of Treasury Challan in this office. Failing which the vehicle will be award to the next lower tender.
8. The undersigned will not be held responsible for any loss damage of the condemned vehicles, if any, if they are not removed within the specified date.
9. The Earnest Money of the successful Tenderer shall be forfeited to Government if he fails to deposit the accepted price and lift the vehicles within the date fixed for the purpose.
10. The Earnest Money of the unsuccessful Tenderer shall be released after the award of Tender to the successful Tenderer.
