CORRIGENDUM & ADDENDUM

In continuation to the RFP No.Com/Trans/RFP/HS/90/2019/53, dated 26th November, 2019 and No.Com/Trans/RFP/HS/90/2019/70, dated 9th December, 2019,

1. In Clause 2.20 (g) the text stating "last 2 financial years" stands amended as "last 3 financial years".
2. In Clause 2.20 (n) the text stating "Should not be involved in any fatal accident in the last 3 years" stands amended as "Should not have been blacklisted by DGCA for any accident in the last 3 years (Self declaration to be attached)".
3. Clause 2.21 (i) A (i) is suffixed with the text "Self Certification from Bidder to be submitted".
4. In Clause 2.21 (v) "Demand Draft" stands replaced with "Bank Guarantee".
5. In Clause 5.2 (ii) the text "Part III Issue III dated 4th August, 2015 stands replaced with "Part IV dated 16th Sep' 2019".
6. In Clause 2.25 of the RFP, the following text stands added as sub-clause 2.25 (i) (e):

"The Government of Meghalaya reserves the right to inspect the Helicopters proposed to be deployed by the Helicopter operator. During the inspection, if the proposed Helicopter is found to be unsatisfactory for carrying out the scope of work as per the RFP, the Government of Meghalaya (GoM) may not award the Contract, or if already awarded, the GoM reserves the right to terminate the contract forthwith".
