**NOTICE INVITING TENDER**

The work of supply, installation, testing & commissioning (including Civil works), of electronic weighbridges (Shallow pit type) as detailed in this tender shall be carried out in accordance with the attached instructions to tenderers, General conditions of contract, special conditions for supply, installation & commissioning, scope of work, schedule, specifications and addenda, if any.

In accordance with Government approval vide letter No.TPT.2/2024/154, dated 28.07.2025, Sealed tenders are invited under two bids system in the prescribed form and on behalf of the Commissioner of Transport, Meghalaya, Shillong for RRC for supply, installation, testing & commissioning of electronic lorry weighbridges (shallow pit type) at **Wageasi, North Garo Hills District** including civil works, as new Weighbridge Hybrid / Electronic Weighbridge of 50 to 100 Metric Tonnes capacity.

The Technical Bid and Price Bid shall be submitted in separate sealed envelopes being clearly superscribed as Technical Bid and Price Bid, both these envelopes containing Technical Bid & Price Bid will be finally put in a sealed envelope super scribing the Tender No. and Name of work.

**Submission of Bids:** penalist

- i) **TECHNICAL BID** with the commercial details should be submitted in the envelope marked '**A – Technical Bid**' along with Earnest Money Deposit payment. Name of the work should be superscribed on the cover.

Bidders have to submit documentary proof of annual turnover, including Audited Balance Sheets and Profit & Loss Accounts for the financial years 2021–2022, 2022–2023, and 2023–2024, duly certified by a Chartered Accountant.

Other supporting documents as specified in the tender document.

- ii) **PRICE BID** should be submitted in a separate envelope marked '**B – Price Bid**'. Price Bid will not be opened on the day and time of tender opening. Price Bids of only such tenderers whose technical bids are found acceptable will be opened subsequently on the date and time fixed by the Government. The date and time of opening the price bids of technically successful tenderers will be intimated to them separately.

iii) **EARNEST MONEY:**

The tenderer is required to deposit along with technical bid of tender Earnest Money of Rs 2,00,000/- (Rupees Two Lakhs only) by Demand Draft or Deposit-at-Call receipt of Scheduled Bank drawn in favour of Commissioner of Transport, Meghalaya, Law-U-Sib, Sawlad, Shillong-793021. Earnest Money Deposit(s) in any other form will not be accepted. Tender(s) not accompanied by a Demand Draft or Deposit-at-Call receipt towards the Earnest Money will be summarily rejected.

**Tender Documents:**

1. One set of tender documents (non-transferable) setting forth details of work to be executed and conditions of contract can be purchased from the office of the Commissioner of Transport, Meghalaya, Sawlad Law-U-Sib, Shillong 793021 from 11.00 A.M. to 4.00 P.M. on all working days on payment of Rs 2000/- (Rupees Two Thousand) only & applicable taxes per set against Pay Order / DD (non-refundable) in favour of the Commissioner of Transport, Meghalaya, Sawlad Law-U-Sib, Shillong, 793021.
2. The tenderer should quote both in figures and in words, the rates tendered by him. In case of any discrepancy in the rates quoted, the amount stated in words shall be treated as authentic.
3. The sale of tender documents will be stopped 5 (Five) days before opening date of tenders.
4. Tenders must reach the Commissioner of Transport, Meghalaya, Sawlad Law-U-Sib Shillong 793021 not later than 3.00 P.M. on 23.09.2023. Technical Bids with commercial details (Marked 'A') will be opened at 3.30 P.M. on the same day in the presence of tenderers or their authorized representatives who may wish to be present.

The Commissioner of Transport reserves the right to accept or reject any or all tenders without assigning any reason whatsoever.

The tendering authority may cancel the tendering process at any stage without assigning any reason.
