## **NOTIFICATION**

In exercise of the powers conferred by Rule 125H of the Central Motor Vehicles Rules, 1989 wherein all Public Service Vehicles as defined Under Section 2(35) of the Motor Vehicle Act, 1988 ('MV Act') and Vehicles requiring /having National permit are mandatorily to be equipped with the Vehicle Location Tracking device ('VLTD') along with one or more emergency button in compliance with the standard of AIS-140 and pursuant to all other instructions of the Ministry of Road Transport and Highways (MoRTH) thereto, the Government of Meghalaya in Transport Department has decided to follow MoRTH's AIS-140 standard with a few modifications in data protocol and data formats to send data from the VLT units to the Command and Control Centre set up by the Government of Meghalaya.

In pursuance with the above mandate, it has been decided that in the first Phase of Implementation, the following categories of vehicles will be fitted with VLTD as per approved specifications by the Empaneled Agencies of the office of Commissioner of Transport, Meghalaya by 30<sup>th</sup> April, 2025.:-

- (i) All Government owned Public Transport vehicles, such buses owned by Urban Affairs/Government Hospitals/Educational & Govt. Training Institution etc.
- (ii) All Public Transport Vehicles owned by PSUs, such as MTC/STEMS/MUDA buses etc.
- (iii) All new vehicles manufactured on and from 01-01-2019 which comes under the purview of rule 125H of CMVR 1989.
